1. I have, or will have, familiarized myself with the Challenger Raceway rules and regulations, including car specifications, safety and procedure rules. I specifically agree to abide by all Challenger Raceway rules.
2. I understand that all cars are subject to inspections at any time by the safety/tech officials. Inspections does not deem that the car is safe. Car safety is the responsibility of the individual competitors.
3. The driver and/or owner assumer responsibility for actions of all members of the race team at any time pertaining to compliance with the rules and regulations while on track property. Driver and/or owner shall be the spokesperson(s) for the car and race team in any matter pertaining to the race event and in any discussion with track officials.
4. I understand and agree that by submitting my race car for various technical and safety inspecitons, that I certify that the race car meets all rules and regulations for the participation in Challenger Raceway sanctioned events. I understand that violation of various rules can result in disqualification and/or loss of winnings for that race event and loss of points for that or all events.
5. I further understand that there is no expressed and/or implied warranty or safety assurance resulting form the publications of/or compliance with the preceeding rules and regulations. They are intended as a guide and are in no way a guarantee against injury or death of participants, drivers, officials or others.
6. The driver and/or car owner must file any protest concerning the race and/or scoring of the race with the pit steward within ten (10) minutes of the finish of the protested race. When necessary, some protest decisions will be made the following week.
